Overview

This how-to documentation will walk users through the steps to sign-in to the NEGIS Portal environments using their single sign on credentials. *Note: For their @nebraska.gov email accounts to work users must be members of Active Directory groups that have access to the NEGIS Portal environments*.



Additional Information

- Go to the portal environment you have been directed to use. If you are testing an application before it is released for agency or public use you will be accessing the NEGIS CAT Portal (Contract Acceptance Testing Portal). If you are new to a team or project and are using an application that is for daily work, then you will be accessing the NEGIS PROD Portal (Production Portal).
- 2. Logging into both portals works the same, but to tell the difference look for the logo.
 - a. The red and blue logo is PROD



b. The blue and gray logo is CAT



Sign-in Steps

- 1. Go to the URL.
 - a. https://gis.ne.gov/portal/home/ (PROD) or
 - b. https://giscat.ne.gov/portal/home/ (CAT)
- 2. Click on the 'Si gn In' button in the upper right hand corner
 - A. Home Gallery Map Scene Groups Help Q. Sign In

3. Select the blue button - 'State of Nebraska'

This should pop -up for all users logging in, if you have already logged in for the first time <u>and</u> are logged into another site u sing your @nebraska.gov account it may auto recognize you and allow you to the site with out this pop -up.

 - 3. Make sure your account is not locked.
 - a. Go to id.nebraska.gov to unlock if necessary.
